Technical and Financial evaluation report of NIT no.WBFBCP/NIT-10(e)/2015-16

For Selection of Architect for Construction of Administrative Building at Siliguri.

The Final Result has been derived on the basis of Quality Cum Cost Based Selection (QCBS). The detailed procedure of selection has been made on QCBS given in clause 12 of the NIT.

Ranking of the bidders (Clause 12.3 of the NIT)

Being QCBS, as per clause 12.3 of the NIT the ranking of bidders has been done on 80:20 = Technical: Financial as follows:

Total Score Secured = 80% of Technical score + 20% of Financial score

The bidder securing highest total score has been ranked 1st and selected for the assignment. Evaluation of technical bids have been done by a committee constituted for the purpose and the result was uploaded in the website on 15.10.2015.

Financial Result sheet

The Financial Bids of the technically qualified (minimum of 50 marks) bidders have been evaluated as per the evaluation criteria mentioned below vide clause 12.2 of the NIT

- a. The total Financial score for evaluation of financial bids is 75.
- b. The list of Bidder has been ranked in ascending order (i.e.) the Bidder who quoted the lowest Value (L1) will be ranked first and so on. For the purpose of this tender, the participating tenderer who have quoted the lowest percentage of the project value as Financial quote, has been ranked L1 and has been assigned 75 points. Other bidders, viz: L2, L3 etc have been compared against the financial quote of the L1 and points assigned accordingly. For example, if the quote of L1 is 2% of the project value and that of L2 is 4% of the project value, then L1 has been awarded 75 points (maximum) and L2 has been awarded (²/₄) x 75 = 37.5 points.
